The International Finance Institutions (IFI) are particularly interesting to the private sector companies for their procurement programs as well as their products and services. In 2015 the value of the WB-financed projects alone exceeded \$56 bn. Each year an average of \$25 billion worth of contracts are awarded through competitive bidding to private sector companies worldwide. BSTDB and, recently, EBRD have an established presence in Greece offering financing to the private sector.

Borrowing countries utilize IFI funds to purchase goods and equipment, carry out civil works and purchase consultant services required for the implementation of development projects. Each project may involve many separate contracts and business opportunities for suppliers, contractors and consultants worldwide. Contracts range in size from several hundred million dollars (for major infrastructure or industrial plants) to a few thousand dollars (for suppliers of goods and services). Contracts are awarded, with few exceptions, through competitive procedures detailed in the IFIs' procurement guidelines. Large and small companies can benefit from the business generated by IFI lending. Some 90% of contracts awarded are below \$ 1million in value and 60% are below 500.000 dollars. Contracts refer to the supply of goods and equipment up to 63%, construction of works, 20% and consultant services, 17%.

The successful participation in the IFI procurement programs is a good opportunity for the development of any company due to the credibility of these institutions and the fact that through the procurement procedures SMEs will gain experience from operating in a very competitive international environment, as well as the prestige that the award of an IFI-financed contract implies.

### **Objective**

The forum is designed for representatives of both suppliers of goods and contractors and consulting firms (business consultants, education-training consultants, legal consultants, IT consultants, architects, engineers etc) that are primarily interested in learning how they can

win contracts in IFI-financed projects. The forum is designed for companies that have some experience but need to deepen their knowledge.

Since the selection of a local partner is very important in the context of procurement when the bidding company is based outside the recipient country, participants will be given the opportunity to form synergies with partners in the Black Sea countries.

In the **first part** the forum aims to familiarize such companies with the IFIs procurement procedures, to give practical advice and point out mistakes that should be avoided.

In the **second part** the forum will offer participants the chance to find partners and form synergies with companies in the Black Sea region, thus increasing their effectiveness abroad as well as to discuss their particular needs or problems they face with IFI procurement specialists.
